## Functions of SMIC

- Organize base line survey and feasibility studies in different parts of the state covering various crops and technologies.
- Ensure smooth implementation of Micro Irrigation Project in different Districts of the State.
- Ensure allocation of State's share of resources required for implementing the Scheme and make it available to the Implementing Agencies at the District Level.
- Finalize and forward the consolidated Action Plan of the Districts to Department of Agriculture and Cooperation, Government of India.
- Circulate the list of system manufactures registered with them along with the price list to the District Micro Irrigation committee (DMIC) and Implementing Agency (I.A.) They will also indicate the quantum of money to be paid by the beneficiary/bank to the manufacturer before installing the system.
- Mobilize credit requirement of the farmers for installing Micro Irrigation System through the Financial Institutions.
- Mobilize credit requirement of the farmers for installing Micro Irrigation System through the Financial Institutions.
- Facilitate Precision Farming Development Centers in organizing various training and extension programme for farmers, officials, NGOs entrepreneurs etc.

- The Committee shall host a website indicating the details and status on the progress of the Micro Irrigation Scheme in different District of the State.

### **Duties and Responsibilities of Member Secretary**

- (i) To take appropriate action a may be necessary to implement the decision of SMIC.
- (ii) Day to day management of the business of the scheme
- (iii) Signing of documents for and on behalf of SMIC
- (iv) Making arrangements for the proper maintenance of various books and record of the agency.
- (v) Convening meeting of SMIC with the consent of Chairperson and maintaining proper records of such meeting.
- (vi) To carry on correspondence on behalf of SMIC.
- (vii) Assisting SMIC in formulation of programmes and work plans.
- (viii) To register the manufactures/suppliers of Micro Irrigation System.
- (ix) To deploy the members of technical Support Group.
- (x) To Perform such other duties and exercising such other powers as may be assigned.

District Micro Irrigation Committee (DMIC) with its headquarter at every District is set up to look after the scheme in District.

### **Function of DMIC**

- Review the Action Plan and forward it to the Ministry of Agriculture through SMIC.
- Mobilize credit requirement of the farmers for installing Micro Irrigation System through the Financial Institutions.
- Monitor and review the physical and financial progress of implementation of MI Scheme
- Review the submission of utilization certificate by the IA.
- Provide feedback to SMIC on monthly basis.

### **Composition of Implementation Agency.**

District Horticulture Mission Implementation Unit shall act as Implementing Agency to implement the scheme in the District.

### **Function of Implementation Agency**

- Formulate Action Plan for their District
- Forward Action Plan to Ministry of Agriculture through DMIC/SMIC.
- Receive funds directly from the Ministry of Agriculture through DMIC/SMIC.
- Disburse the assistance to the beneficiaries.
- Furnish Utilization Certificate and Monthly Progress Report to Ministry of Agriculture through DMIC/SMIC.
