Decision: DPCs will complete the target at the end of August month in addition to complete the backlog also if any.

2. Status of Mobilization Fund Utilization by FPOs: Funds of Rs 20,000/- has been released in the account of 17 FPOs as an advance for the Ist year on A/c of "Mobilization of farmers to form FPOs". After discussion, it is found that no FPO has conducted such type of activity for mobilization of farmers so far. Therefore all DPCs are strictly advised that they will make proper liaison with the respective FPO for timely utilization of these funds as per norms. DPCs were further directed to submit the report of this component in the prescribed performa every month in the review meetings.

Agenda 3: Progress of enlistment of FPOs:

Progress was reviewed for enlistment of FPO who has enrolled 150 or more farmer on SFACH Portal or issued share certificate to its members and it has been found that progress in this regard is very slow. DPCs were directed to send cases of such FPO on priority basis to SFACH for enlistment. It was further mentioned that handholding & Management incentives will only be given to such FPOs who are enlisted with SFACH.

Agenda 4: Progress of Various Compliances by FPOs:

Progress of Various Compliances to be followed by FPO after registration of Farmer Producer Company under Companies Registration Act-2013 was reviewed. DPC has told that various mandatory compliances has been completed by the respective FPO to whom H & M incentives has been released by SFACH. The FPOs recently registered have also been sensitized to complete such compliances within timeline end is under progress.

Agenda 5: Marking of Attendance on App.:

Few of the DPC and CPC has informed that their travelling plan is not reflected on Vodaphone App on the respective date of their travel in the field while they are actually traveling for field duties on such dates.
