4. Payment to firm:

- a) Payment will be reimbursed by SFACH on submission of claim by firm upon generation of CIN.
- b) The claim bill will be submitted directly to SFACH, HQ.

5. Cancelation of Empanelment:

- a. If any empaneled firm violate the instructions/terms & conditions and does not provide after registration of Farmer Producer Organization under Indian Company Act, 2013, services properly well in time, its empanelment shall be cancelled.
- b. The firm will be liable to execute the work within the stipulated time period as mentioned in scope of work. If the firm fails to do the same with in the said period time firm will be liable to pay the penalty @ 5% of the financial bid accepted in the first 15 days of default and @ 10% of next 15 days of default, thereafter his empanelment shall be cancelled. The penalty amount will be recovered from the financial bid charged fee of the empaneled firm.

6. Arbitration and Jurisdiction:

- (a) All disputes of differences relating to empanelment of firms and work shall be referred to the Managing Director, Small Farmers Agribusiness Consortium Haryana.
- (b) If the dispute is not resolved, the matter will be referred to a Sole Arbitrator to be appointed by Additio with the "Arbitration and Conciliation Act 1996". The arbitration shall be held in Chandigarh India and the language English only.
- (c) Subject to the above, the Courts at Panchkula alone only shall have jurisdiction in the matter.
