MINUTES OF 57th MIDH MEETING HELD ON DATED 10.01.2020 AT 10:30 AM AT HTI, UCHANI, KARNAL UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

List of the participants is annexed at Annexure-A.

The meeting was started by welcoming all the members. The agenda was discussed and actions taken are as under:-

Agenda No. 1: Confirmation of the proceedings of 56th MIDH meeting.

The minutes of 56th MIDH meeting which was held on dated 07.12.2019 were circulated vide memo no.7956-77/Hort-APO/NHM/5/XI/IV dated 09.12.2019 to all concerned. As no comments were received from any quarter, so the minutes of 56th meeting were confirmed.

Agenda No. 2: Action Taken Report of previous meetings.

MIDH56/3	Review of component-wise up to date- monitoring of strawberry fields.	MD instructed DHC Rohtak to monitor all districts of strawberry and submit the compliance report to the HQ. She was also directed to contact In-charge PTC, Shamgarh and submit the proposal for potato seed production program under MIDH for the year 2020-21.
MIDH56/3	Review of component-wise up to date- monitoring of Protected structures.	The monitoring of protected structures of Ambala and Panchkula was done by DDH/N and PSE-II. - Action Completed.
MIDH56/3	Review of component-wise up to date- time-bound sanctions in case of Individual tanks, Pack houses, Low cost onion storage structures etc.	All MS, DHMIUs were directed to start the work of Pack house, Onion storages and individual tanks for which sanction have already been issued by the HQ. It may also be ensured all such type of works should be completed before 31.03.2020., no case should be pending for liabilities for next FY as the cost norms are going to be revised.

Agenda No. 3: Review of Component-wise progress up to date.

MD reviewed the Component-wise Physical & Financial achievements under MIDH scheme. There is an expenditure of Rs. 7903.46 lakhs out of total approved outlay of Rs. 16587.85 lakhs which is approx. 47.64% achievement (including committed liabilities). MD has taken the matter seriously & directed all the field functionaries to achieve the targets of their Annual Action Plan accordingly. The assistance in the components based on seasonal crops should be released well in time.

The physical and financial achievement of District Yamunanagar, Kurukshetra, Mewat, Jhajjar, C. Dadri, Sirsa and Rohtak was found below 40%. It was seriously viewed by MD and instructed Establishment Officer to take appropriate action against the MS, DHMIUs/DHCs of these districts.

MS, DHMIU Karnal told that the seed of cucumber is being sold by Ms Kissan Sewa Centre, Shahbad at higher rate in comparison to Punjab state. In this regard, MD instructed DHO Kurukshetra to take action against the dealer.

(Action to be taken by: All Concerned)

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2019-20.

MD instructed to send cases of additional assistance of 15% for protected structures for release of funds after inspection from DMC. MD also instructed all MS, DHMIUs to expedite the final inspection of protected structures, if pending and submit the cases for release of assistance to HQ without delay.

(Action to be taken by: Concerned MS, DHMIUs)

Agenda No. 5: Review of progress of SCSP component under MIDH scheme up to date.

It was intimated that the report of SCSP component under MIDH for the month of December, 2019 has been received from all the quarter. The achievements of District Bhiwani, Jhajjar, Kurukshetra, Mewat, Palwal, Sirsa and Sonipat were found very low. MD directed to utilize the 16.6% funds of total Annual Action Plan of their district well in time for SC farmers.

(Action to be taken by: Concerned MS, DHMIUs)

Agenda No. 6: Target & achievements of DBT under MIDH for 2019-20.

The physical targets & achievement of beneficiaries covered under MIDH through DBT during 2019-20 was not reviewed due to not working of HORTNET portal. However, MD instructed all MS, DHMIUs to achieve their physical targets of DBT before 31.03.2020.

(Action to be taken by: All MS, DHMIU)

Agenda No.-7: Power point presentation by DHCs on Protected Structures.

The power point presentation regarding protected structures was made by DHC Ambala. MD instructed remaining DHCs to give presentation in next coming meetings. The visits of protected structures at farmers' field should be done on regular basis.

Agenda No.-8: Any other item with the permission of Chair.

8.1: Annual Action Plan for the year 2020-21.

MD instructed all MS, DHMIUs to prepare Annual Action Plan for the year 2020-21 after consultation with the Members of DHMIU, Kisan clubs, Progressive farmers and the same may be got approved from the Chairman of DHMIU. The Annual Action Plan for the year 2020-21 have to be submitted to HQ up to 31.01.2020.

The meeting ended with a vote of thanks to the Chair.
