MINUTES OF 58TH MIDH MEETING HELD ON DATED 03.02.2020 AT 04:00 PM THROUGH VIDEO CONFERENCE UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting was started by welcoming all the members. The agenda was discussed and actions taken are as under:-

Agenda No. 1: Confirmation of the proceedings of 57th MIDH meeting.

The minutes of 57th MIDH meeting which was held on dated 10.01.2020 were circulated vide memo no.8793-812/Hort-APO/NHM/5/XI/IV dated 13.01.2020 to all concerned. As no comments were received from any quarter, so the minutes of 57th meeting were confirmed.

Agenda No. 3: Review of Component-wise progress up to date.

MD reviewed the Component-wise Physical & Financial achievements under MIDH scheme. There is an expenditure of Rs. 8698.41 lakhs out of total approved outlay of Rs. 16587.85 lakhs which is approx. 52.44% achievement (including committed liabilities). MD has taken the matter seriously & directed all the field functionaries to achieve the targets of their Annual Action Plan accordingly. The assistance in the components based on seasonal crops should be released well in time. There should not be any pending liabilities/Spill over activities for the next FY as the cost norms are going to change from next FY onwards. If any case of onion storage, Pack house, Community tank, individual tank etc remains incomplete during the FY then the concern MS, DHMIU will be held responsible.

MD instructed all MS, DHMIUs that the plantation of crops under protected Structures should be done before 25th Feb 2020 as the proper utilization of protected structures could be done.

For proper utilization of funds, the protected structures and other components be monitored regularly by the concern MS, DHMIUs and DHCs.

Sanction for 15 nos pack house has already been issued to MS, DHMIU Karnal during 2019-20 but till date even a single pack house has not been constructed. In the meeting MS, DHMIU Karnal assured that the status will be disposed off within a week.

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2019-20.

The additional assistance of 15% as State Share for protected structures was reviewed by MD. A total of Rs. 7.34 crore has been utilized so far. MD instructed to send cases of additional assistance of 15% for protected structures for release of funds after inspection from DMC. MD also instructed all MS, DHMIUs to expedite the final inspection of protected structures, if pending and submit the cases for release of assistance to HQ without delay.

Agenda No. 5: Review of progress of SCSP component under MIDH scheme up to date.

It was intimated that the report of SCSP component under MIDH for the month of January, 2020 has been received from all the quarter. The achievements of District Bhiwani, Jhajjar, Kurukshetra, Mewat, Palwal, Sirsa and Sonipat were found very low. MD directed to utilize the 16.6% funds of total Annual Action Plan of their district well in time for SC farmers. If required an advertisement may also be given in the newspaper and special training camps may be organized so that SC beneficiaries may be motivated to take the benefits of the scheme.

Agenda No. 6: Target & achievements of DBT under MIDH for 2019-20.

The physical targets & achievement of beneficiaries covered under MIDH through DBT during 2019-20 was reviewed by MD. So far, 17403 beneficiaries has availed subsidy against a target of 25800 under the scheme. MD instructed all MS, DHMIUs to achieve their physical targets of DBT before 31.03.2020.
