MINUTES OF 59TH MIDH MEETING HELD ON DATED 07.03.2020 AT 10:30 AM AT HTI, UCHANI, KARNAL UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

List of the participants is annexed at Annexure-A.

The meeting was started by welcoming all the members. The agenda was discussed and actions taken are as under:-

Agenda No. 1: Confirmation of the proceedings of 58th MIDH meeting.

The minutes of 58th MIDH meeting which was held on dated 03.02.2020 were circulated vide memo no.9240-59/Hort-APO/NHM/5/XI/IV dated 05.02.2020 to all concerned. As no comments were received from any quarter, so the minutes of 58th meeting were confirmed.

Agenda No. 2: Action Taken Report of previous meetings.

MIDH56/3	Review of component-wise up to date- Proposal for seed production.	DHC Rohtak has submitted the proposal for seed production of potato. MD instructed to include the same in the Annual Action Plan for the year 2020-21. -Action completed.
MIDH57/3	Review of component-wise up to date- low achievement.	The progress of district Kurukshetra, Jhajjar, Mewat and Yamunanagar is satisfactory. MD instructed to achieve the targets accordingly in this FY. -Action completed.
MIDH57/3	Review of component-wise progress up to date -Seed of cucumber being sold at a higher rate.	Action is awaited with MS, DHMIU Kurukshetra. After passing a period of one month the concerned MS, DHMIU has taken no action against the seed dealer. MD directed to take the action within a week and submit the report to HQ otherwise Govt. may be requested to

		take strict disciplinary action against him.
MIDH58/3	Review of component-wise progress up to date- Plantation of crop under protected structures.	It was discussed in the meeting that the assistance on cultivation of crop in protected structures must be released after growing the crop before 25 th March 2020 accordingly. -Action completed.
MIDH58/3	Review of component-wise progress up to date- Sanction of pack houses.	MS, DHMIUs Karnal have some pending cases of pack house. He assured that he will take appropriate action accordingly and intimate the HQ soon.

Agenda No. 3: Review of Component-wise progress up to date.

MD reviewed the Component-wise Physical & Financial achievements under MIDH scheme. There is an expenditure of Rs. 10401.65 lakhs out of total approved outlay of Rs. 15616.65 lakhs which is approx. 66.61% achievement (including committed liabilities). MD directed all the field functionaries to achieve the targets before 25th March 2020 of their respective Annual Action Plan as the FY is going to end soon. There should not be any pending liabilities/Spill over activities for the next FY as the cost norms are going to change from next FY onwards. If any case of onion storage, Pack house, Community tank, individual tank etc remains incomplete during the FY then the concern MS, DHMIU will be held responsible.

MD instructed DHC Aromatics to cover atleast 50% of the targets under the component of Aromatic plants as the achievement is low. Further, DHC Aromatics be directed to tie up with all MS, DHMIUs/DHCs directly to finalize the Annual Action Plan for the year 2020-21 under Aromatic Plants.

MD instructed that exposure visit/training on spices of field functionaries (MS, DHMIUS/DHCs/FCs) may be arranged at Calicut and Goa in this month or next month positively.

MS, DHMIU Karnal has pointed out that the renowned/eminant resources person from various institutes like ICAR/SAU may be called at HTI to deliver their lectures.

MD agreed for the same and instructed Principal HTI to make a panel of such resource persons.

(Action to be taken by: Principal HTI, All MS, DHMIUs, DHCs, DHC Aromatics)

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2019-20.

The additional assistance of 15% as State Share for protected structures was reviewed by MD. A total of Rs. 9.40 crore has been utilized so far. MD instructed to send cases of additional assistance of 15% for protected structures for release of funds before 25th March 2020 after inspection from DMC. MD also instructed all MS, DHMIUs to expedite the final inspection of protected structures, if pending and submit the cases for release of assistance to HQ without delay.

(Action to be taken by: Concerned MS, DHMIUs)

Agenda No. 5: Review of progress of SCSP component under MIDH scheme up to date.

It was intimated that the report of SCSP component under MIDH for the month of February, 2020 has been received from all the quarter. The achievements of District Bhiwani, Jhajjar, Kurukshetra, Mewat, Palwal, Sirsa and Sonipat were found very low. MD directed to utilize the 16.6% funds of total Annual Action Plan of their district well in time for SC farmers. MD directed EO to call explanation of low achieving districts and report within a week accordingly.

(Action to be taken by: EO and Concerned MS, DHMIUs)

Agenda No. 6: Target & achievements of DBT under MIDH for 2019-20.

The physical targets & achievement of beneficiaries covered under MIDH through DBT during 2019-20 was reviewed by MD. So far, 19983 beneficiaries has availed subsidy against a target of 26650 under the scheme i.e. 74.98%. MD instructed all MS, DHMIUs to achieve their physical targets of DBT before 25.03.2020.

(Action to be taken by: All MS, DHMIU)

Agenda No. 7: Submission of Annual Action Plan for the year 2020-21.

MS, DHMIUs have submitted the tentative allocation to be made in their respective district amounting to Rs. 200.97 crores for the year 2020-21 under MIDH. The proposal may be appraised to SLEC for approval of tentative Annual Action Plan for the year 2020-21 so that the same may be forwarded to GoI.

(Action to be taken by: All MS, DHMIU)

Agenda No. 8: Power-point presentation by DHCs on protected structures.

The power point presentation regarding protected structures was made by DHC Ambala, Jhajjar, Gurugram and Charkhi Dadri. The visits of protected structures at farmers' field should be done on regular basis.

Agenda No.-9: Any other item with the permission of Chair.

The meeting ended with a vote of thanks to the Chair.
