MINUTES OF 61st MIDH MEETING HELD ON DATED 22.05.2020 AT 11:30 AM THROUGH VC UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting was started by welcoming all the members. The agenda was discussed and actions taken are as under:-

Agenda No. 1: Confirmation of the proceedings of 60thMIDH meeting.

The minutes of 60th MIDH meeting which was held on dated 16.04.2020 were circulated vide memo no.10731-49/Hort-APO/NHM/5/XI/IV dated 17.04.2020 to all concerned. As no comments were received from any quarter, so the minutes of 60th meeting were confirmed.

Agenda No. 2: Action Taken Report of previous meetings.

Agenda No. 3: Expenditure Statement for the month of April 2020.

MD reviewed the expenditure statement for the month of April 2020. MD directed all MS, DHMIUs that the SC beneficiaries should be considered in every component under the scheme.

MD informed all MS, DHMIUs to focus on increasing the area under Area Expansion of fruits and vegetables. All MS, DHMIUs along with DHCs will identify the site and arrange planting material for maintenance & new plantation and prepare a excel sheet for the same. As per the instruction issued by GoI vide its letter no. F.No. 18-3/2020-MIDH (ii) dated 29th April 2020, 30% funds of the total allocation i.e. Rs. 200.00 crore may be taken up pertaining to emergent requirement in view of the prevailing situation due to COVID-19. The components which will be covered are Area Expansion of new orchards, Maintenance of 1st and 2nd year of Area expansion, Cultivation of hybrid vegetable, Spices, IPM&INM, Mulching, Mechanization, Community water tanks etc.

(Action to be taken by: All MS, DHMIUs & DHCs)

Agenda No. 4: Monitoring of fields by MS, DHMIUs/DHCs/FCs.

MD directed all DHCs/FCs to monitor the fields regularly. He also asked to upload the pics of the field on the spot on MIDH Haryana whatsapp group, also the uploading should be done between the official timing i.e. 9 A.M. to 6 P.M. after that no photo will be acceptable. DHCs/FCs will make entry in the movement register before visiting the field, so that MS, DHMIUs can keep track on the fields visited by DHCs and their movement in fields. All the MS, DHMIUs/DHCs/FCs ensure to identify the beneficiaries for laying out of orchards and submit the report regularly (like layout, digging of pits etc).

(Action to be taken by: All MS, DHMIUs and DHCs)

Agenda No. 5: Status of salary released for the month of March and April, 2020 and requirement of funds for salary.

It was informed in the house that the salaries of all DHCs have been released except Mewat, Narnaul and Sirsa. MD directed MS, DHMIU Mewat, Narnaul and Sirsa to release the salary for the month of March and April 2020. The concerned MS, DHMIUs are directed to release the salary today positively.

(Action to be taken by:EO and Concerned MS, DHMIUs)

Agenda No. 6: Review of timeline components under MIDH.

It was discussed in the video conference that the activities related to Area Expansion of new orchards, Maintenance of 1st and 2nd year of Area expansion, Cultivation of hybrid vegetable, Spices, IPM&INM, Mulching, Mechanization, Community water tanks etc shall be taken up on priority basis accordingly.

MD informed the house about 'Mera Pani Meri Virasat' Scheme launched by Hon'ble CM, Haryana to support crop diversification in the state. He instructed all MS, DHMIUs to hold maximum farmer meetings to achieve assigned targets under 'Mera Pani Meri Virasat' Scheme which are being circulated shortly.

(Action to be taken by: All MS, DHMIU)

Agenda No. 7: Procurement of Horticulture produces during lockdown.

MD directed MS, DHMIUs Sirsa and Yamunanagar to coordinate to keep track on the production, procurement, supply and transportation of Sapota and Mango in the state.

(Action to be taken by: MS, DHMIU Sirsa and Yamunanagar)

Agenda No.-8: Submission of fortnight report of DHCs.

MD directed all DHCs to submit their fortnight report to respective MS, DHMIUs on time. It was also decided in the house that the salaries of such DHCs should not be released unless and until the fortnight report is submitted. The pending reports of DHCs who have not submitted the fortnight report for the month of April and May were directed to submit it till Wednesday i.e. 27.05.2020.

Agenda No.-9: Any other item with the permission of Chair.

- 1. MS, DHMIUs raised the point that some farmers after making 50% payment doesn't complete their work which doesn't achieve the motive of the scheme. He suggested that only 30% payment after completion of civil work be made to the beneficiary and rest of payment after completion of complete work i.e. plantation and MI system. The matter was discussed in detailed in the house. After discussion, it was decided that 30% assistance will be given after completion of all civil work and remaining 70% will be given after plantation & drip installation.
- 2. If Govt. vehicle is not available for monitoring of horticulture activities in the field, then field functionaries may monitor using their own motorcycle and the T.A. will be paid as per T.A. rules.
