MINUTES OF 62nd MIDH MEETING HELD ON DATED 19.06.2020 AT 11:00 AM THROUGH VC UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting was started by welcoming all the members. The agenda was discussed and actions taken are as under:-

Agenda No. 1: Confirmation of the proceedings of 61st MIDH meeting.

The minutes of 61st MIDH meeting which was held on dated 16.04.2020 were circulated vide memo no.247-66/Hort-APO/NHM/5/XI/IV dated 26.05.2020 to all concerned. As no comments were received from any quarter, so the minutes of 61st meeting were confirmed.

MD reviewed the expenditure statement for the month of May 2020. MD directed all MS, DHMIUs that except salary no other expenses should be done at district level. If required, then sanction should be taken from HQ before releasing the required amount.

Agenda No. 4: Monitoring of fields by MS, DHMIUs/DHCs/FCs.

MD directed all field functionaries i.e. DHCs/FCs to monitor all the MIDH activities accordingly and upload the pics of the field on the spot on MIDH Haryana whatsapp group.

(Action to be taken by: All MS, DHMIUs and DHCs/FCs)

Agenda No. 5: Review of timeline components under MIDH.

MD instructed all MS, DHMIUs/DHCs to upload the cases of liabilities for the year 2019-20 within a week further he also instructed to upload the cases of maintenance of fruits 1st and 2nd year, Hybrid seed, IPM/INM etc. He also stressed upon focusing on the farmers who have diversified from paddy to horticulture crop.

It was directed by MD that MS, DHMIUs/DHCs/FCs/Supervisor will give one-to-one practical training to farmers under protected structures as the training under MIDH has been restricted due to Covid19 pandemic for the year 2020-21 by GoI. The training should be provided before issuing the administrative approval or before release of 1st instalment to the concerned farmer. MS, DHMIUs will certify that the technical know-how has been provided to the concerned beneficiary.

MD directed all MS, DHMIUs to utilize 16.6% of funds of AAP 2020-21 under SCSP beneficiaries.

It was also discussed in the house that the receipt of all applications should be issued once received in the office of MS, DHMIUs. Based on the merit of these applications, the registration should be done on HORTNET as the benefit is being provided on the basis of First-come-First-serve. No application should be pending at MS, DHMIU level.

(Action to be taken by: EO and Concerned MS, DHMIUs/DHCs/FCs) Agenda No. 6: Review of MPMV Scheme for the year 2020-21.

MD informed the house that the work under 'Mera Pani Meri Virasat' Scheme to support crop diversification in the state is being run smoothly. As per the performa circulated earlier, performance under Group-A is unsatisfactory. MD instructed the officer in-

charge of Group-A to focus on achieving the targets as committed. Where-in the achievement under Group-B is found excellent. MD appreciated the efforts made by the field functionaries.

MD also instructed to follow the instructions issued by Department of Agriculture and Farmers' Welfare, Govt. of Haryana for verification of area sown under MPMV Scheme.
