MINUTES OF 45th MIDH MEETING HELD ON DATED 02.01.2019 AT 10:00 AM THROUGH VIDEO CONFERENCE UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting through Video Conference (VC) was started by welcoming all the members and the agenda was discussed and actions taken are as under:

Agenda No. 1: Confirmation of the proceedings of 44th MIDH meeting.

The minutes of 44th MIDH meeting which was held on dated 06.12.2018 were circulated vide memo no. 5924-45/Hort-APO/NHM/5/XI/IV dated 13.12.2018 to all concerned. As no comments were received from any quarter, so the minutes of 44th meeting were confirmed.

Agenda No. 2: Action Taken Report of previous meetings.

Due to paucity of time of the slot for VC room the ATR of previous meetings was not taken up. The same will be considered in next meeting.

Agenda No. 3: Review of Component-wise progress up to date.

MD reviewed the Component-wise Physical & Financial achievements under MIDH scheme. There is an expenditure of Rs. 7201.22 lakhs out of total approved outlay of Rs. 18333.33 lakhs which is approx. 39.28% achievement (including committed liabilities). MD has taken the matter seriously as nine months of the year has been completed & directed all the field functionaries to expedite the progress to achieve the targets. MD directed EO/C/IT to initiate action against low achieving districts.

MD instructed MS, DHMIU, Gurugram to conduct training for two days (on 18.01.2019 & 19.01.2019) of all the Horticulture Supervisors engaged under MIDH at Horticulture Training Centre, Gurugram.

MD instructed JDH/N to conduct one day training of all MS, DHMIUs and DHCs at HTI, Uchani, Karnal on 19.01.2019 reg. implementation and preparation of PHM projects in coordination with Principal, HTI, Uchani Karnal.

MS, DHMIU, Yamunanagar and other districts requested to allow the release assistance of equipments and machinery in such cases where firms are not empanelled. MD allowed the same subject to the condition that the concerned beneficiary will be responsible for the quality. Further, the individual sanctions should be obtained from HQ in such cases.

MD directed all MS, DHMIUs to verify the components in the fields under MIDH as per the criteria fixed in the 43rd MIDH staff meeting and upload the day to day monitoring activities on "MIDH Haryana" whatsapp group.

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2018-19.

The report of additional assistance of 15% as State Share for protected structures is being submitted regularly by MS, DHMIUs to PSE-I. The funds from State Govt. for addition 15% assistance for the year 2018-19 are not released so far. MD instructed SAO to follow the matter to release 15% assistance from State govt.

The MS, DHMIUs informed that the reports has been sent to PSE-I. MD instructed to put up the same on file.
