CIRCULAR: BBY - 1

Subject: Implementation of Bhavantar Bharpayee Yojana (BBY) – Instructions regarding.

Govt. of Haryana, while taking cognizance of issue related to low prices of horticulture produce in wholesale market, has launched Bhavantar Bharpayee Yojana (BBY) on dated 30.12.2017 to be effective from 01.01.2018. The purpose of the scheme is to incentivize the farmers during low prices of their produce in the markets. All the officers of department have already been sensitized and made aware of the programme in the last staff meeting held on dated 08.12.2017 and again on 04.01.2018. To implement this scheme, following instructions are to be followed by all the Officers of Department:

- 1. Department has uploaded the scheme description on its website hortharyana.gov.in for general awareness, DHO will make use of this link both in Hindi and English for further dissemination.
- 2. DHO to ensure proper implementation of the scheme. The details of the crops selected, secured/ protected price, benchmark yield, producer registration, registration period, verification period, appeal period and sale period has been defined and are as under:
 - a) <u>Crops selected</u> Potato, Onion, Tomato and Cauliflower
 - b) Crop wise secured/ protected Price and Benchmark Yield:

- d) Major highlights of the scheme have been incorporated in the publicity material of BBY (Annexure-1), the copies of which can be replicated for further distribution. However, 1000 printed copies of this material for each district shall be made available during workshop on 10.01.2018 for further awareness and distribution to the farmers.
- e) All concerned officers to perform their roles and strictly follow the various timelines and guidelines mentioned under the scheme.
- 3. Registration of all producers shall be done online and on e-portal.
 - a. A registration link for registration of farmers has also been provided on the website of Horticulture Department and HSAMB.
 - b. Instructions/ procedures for farmers' registration are available on these links, however copy of which is attached in Hindi and English (Annexure -1&2), same can be used to make aware the farmers about their registration process.
- 4. Upon registration, the area shall be authenticated by Revenue Officers duly assisted by Horticulture Development Officers.
 - a. Block level user ID and Password has been generated on E-portal of scheme.
 - b. During verification period, each HDO to check the applications registered on the e-Portal daily and will contact concerned Revenue Officer to verify the area in view of details entered by the farmer on the e-portal.
 - c. DHO to submit report of district to Directorate of Horticulture on weekly basis regarding no. of cases verified against registration and appeals disposed off.
 - d. It is to be noted that any producer who is land owner, lease holder or tenant is eligible under the scheme.
- 5. Awareness camps will be organized by DHO in district in the major growing areas of horticulture crops preferably in crop clusters sites.
 - a. Tentative schedule has been attached for timely action (Annexure-3).
 - b. DHO will tie-up with DMEO and DPRO for their participation and coverage.
 - c. It is also to ensure to make wide publicity of the event through online, offline, digital & print media.
- 6. Govt. has issued order vide dated 03.01.2018 (Annexure-4) and deputed Senior Officers to chair Awareness Generation Sessions, all DHOs have to coordinate with DMEO to conduct these sessions.
- 7. District Level Monitoring Committee (DLMC) under the chairmanship of Deputy Commissioner of respective district has been constituted. Each DHO to attend this meeting in person and actively involved in proceedings of the meeting with proper follow up. The composition of DLMC is as under:

i. Deputy Commissioner : Chairman
ii. Deputy Director Agriculture : Member
iii. District Manager NABARD : Member
iv. District Horticulture Officer : Member

v. District Revenue Officer : Member : Member

vi. DMEO, HSAMB : Member Secretary

- 8. Each DHO to coordinate closely with District Marketing Enforcement Officer (DMEO) and have fortnightly meeting with them.
- 9. In each office, the detailed description of scheme shall be made available in already created help desk with prominently displaying BBY scheme in the front.
- 10. A State Level Workshop shall be held on dated 10.01.2018 at CSSRI, Karnal and all the officers and officials (including DDH, DHOs, Food Technologist, Subject Matter Specialist, Trainers/ Technical staff at HTI, HDOs, Supervisors, Data Entry Operators and Fieldmen) shall attend the same for detailed deliberation and implementation strategy.

Instructions/ Procedure for Farmer Registration

HSAMB has introduced a procedure for online Farmer Registration, now farmer can register online.

The followings are the Instructions/Procedure for Farmer Registration:

- 1. All (*) Marked fields are Mandatory to be filled.
- 2. Aadhar Card number should be of 12 digits.
- 3. Mobile Number should be of 10 digits.
- 4. Fill correct Mobile Number. The information will be sent on the registered mobile number through SMS.
- 5. Date of birth should match with ID proof.
- 6. All documentary proof to be uploaded.
 - a. Farmer's can submit Scanned/Photo copy of any one of the following id proof:-
 - 1. Aadhar card
 - 2. Driving License
 - 3. Passport
 - 4. Voter ID
 - b. Passport size photograph of Farmer registering under this scheme.
 - c. Photocopy of First Page of bank passbook for the account number details of the farmer.
 - d. Size Limit to upload document or image is 2 MB.
 - e. Click on Upload button and browse the file to be uploaded.
- 7. Following details are required for filling Bank details:
 - a. Bank Name: Select Bank Name from the given dropdown
 - b. IFSC code: IFSC code should match as per bank name given.
 - c. Account Number: Enter Farmer Account Number.
 - d. Confirm Account Number: Account Number should match with given account number.
 - e. Account Holder Name: Account holder name should match with the bank account details given.
 - f. Upload First Page copy of bank passbook having the account number details of the farmer.
- 8. Click on Submit button.
- 9. On clicking Submit button the form of sowing details of the crop will open. Following details are required to be filled:
 - a. Scheme Name
 - b. Crop Year
 - c. Commodity
 - d. Area in Acre
 - e. Kila number: Enter Kila number where the cultivation has been done for e.g. o 101,102,103
 - f. Land Type- Fill the type of land (Land Owner, Lease, Tenant or Combined)
- 10. Click on Save button.
- 11. Print the acknowledgment slip.
