MINUTES OF 37th MIDH MEETING HELD ON DATED 14.05.2018 AT 09:30 AM AT CONFERENCE HALL, DIRECTORATE OF HORTICULTURE UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

Joint Director NHM welcomed all the participants & W/Mission Director. From prior permission of MD, meeting was started and agendas were discussed as under:

Agenda No. 1: Confirmation of the proceedings of 36th MIDH meeting.

The minutes of 36th MIDH meeting was held on dated 13.04.2018 were circulated vide memo no. 417-53/Hort-APO/NHM/5/XI/IV dated 23.04.2018 to all concerned. As no comments were received from any quarter, so the minutes of 36th meeting were confirmed.

Agenda No. 2: Action Taken Report of previous meetings.

The action taken report on the decisions taken in the previous meetings of MIDH was reviewed in detail and the following decisions were taken:-

Agenda No. 3: Component-wise review of Physical & Financial committed Liabilities/Spill over activities under MIDH scheme for the year 2017-18.

MD reviewed the Component-wise review of Physical & Financial committed Liabilities/Spill over activities under MIDH scheme for the year 2017-18. MD instructed concerned MS, DHMIUs to achieve the physical & financial spill over activities & upload the same at the earliest possible accordingly.

MD instructed all MS, DHMIUs to start registration of beneficiaries on HORTNET under the various components of MIDH so that the physical & financial targets could be achieved well in time.

Agenda No. 4: Review of progress of SCSP component (only committed Liabilities/Spill over activities) under MIDH scheme for the year 2017-18.

MD reviewed the progress of committed Liabilities/Spill over activities of SCSP component under MIDH scheme for the year 2017-18. MD instructed concerned MS, DHMIUs to achieve the physical & financial spill over activities under SCSP & upload the same at the earliest possible accordingly.

Agenda No. 5: Submission of beneficiary list for the year 2017-18 under MIDH.

All districts except Fatehabad have submitted their Hard copy of beneficiary list. District Mewat, Karnal, Sonipat & Yamunanagar had not submitted their soft copy of Beneficiary list.

Agenda No. 6: Power point presentation by concerned DHCs on protected structures.

DHCs of District Panchkula, Sonapat & Sirsa gave presentation on protected structures that have been visited by them. MD instructed all DHC to make the presentation as per the format circulated earlier. Presentation of remaining DHCs will be taken in next meeting. All the DHCs were directed to educate the beneficiaries of

protected structure regarding crop cultivation, maintenance, insect-pest and disease, infestation of nematodes and to protect their structure from natural calamities (i.e. high wind velocity, storm etc.). Further it was also ordered by MD to upload the suggested measures to farmers by DHCs in this regard on MIDH Haryana whatsapp group.

Agenda No. 7: To discuss the District level AAP for SCSP under MIDH for the year 2018-19.

The district-wise AAP for SCSP component under MIDH for the year 2018-19 was finalized after discussion. MD instructed all MS, DHMIUs to strictly follow the instruction issued by GOI which were circulated on dated 14.05.2018 along with the approved Annual Action Plan for the year 2018-19.

Agenda No. 8: To discuss the Block level AAP under MIDH for the year 2018-19.

As per the instruction of GOI, the District Annual Action Plan should be prepared on the basis of Annual Action of blocks of that district and achievement of different targets of AAP be achieved accordingly. The block level Annual Action Plan of all districts have already been finalized & circulated to all MS, DHMIUs still if any MS, DHMIU wants to change in the block level Annual Action Plan may intimate the HQ within a week.

Agenda No. 9: Review of Progress of Centre of Excellence.

The progress of Centre of Excellence/ IHDC Hodal, Sondhi & Sunderah was reviewed by Mission Director. MD instructed to expedite the progress and execute the work as per the DPR. It was also directed by MD to In-charge IHDC Hodal (Palwal), Sunderah (Narnaul) and Centre of Excellence for Flowers Sondhi (Jhajjar) to give PPT in the next meeting.

1. Plastic crates shall be distributed to beneficiaries under project based activities. It should be distributed to FPO/FIGs, Owner of Cold Storages and vegetable vendors on project based. Subsidy on GST shall not be permissible.
2. MD instructed Principal HTI to conduct training for all DHC on 18th & 19th May 2018 on topic "Package practices for Cultivation of Vegetable/Flower crops etc. in protected structures as well as open fields". Every MS, DHMIU will send the DHC & all supervisors.
