Agenda No. 3: Review of Component-wise progress up to date.

MD reviewed the Component-wise Physical & Financial achievements under MIDH scheme. There is an expenditure of Rs. 6110.63 lakhs out of total approved outlay of Rs. 20988.65 lakhs which is approx. 29.11% achievement. MD has taken the matter seriously as about eight months of the year is going to be completed & directed all the field functionaries to expedite the progress to achieve the targets. Following decisions were taken during the review:

MD directed concerned MS, DHMIUs to achieve the targets of rejuvenation by December end. It came to notice that there are some cases of Community water tanks pending in District Sirsa since long time. It was directed to prepare a seniority list strictly

on merit basis as per availability of budget duly certified by MS, DHMIU Sirsa & DHC & submit the same to HQ. The remaining cases may be filed & to be intimated to the applicants by registered post.

DHC Hisar informed that one computer operator & one clerk engaged under MIDH are not doing the work of MIDH. It is a great lapse on part of MS, DHMIU Hisar. MD instructed EO to look into the matter & submit the report within 15 days.

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2018-19.

The report of additional assistance of 15% as State Share for protected structures is being submitted regularly by MS, DHMIUs to PSE-I. The funds from State Govt. for addition 15% assistance for the year 2018-19 are not released so far. MD instructed SAO to follow the matter to release 15% assistance from State govt.
