MINUTES OF 44th MIDH MEETING HELD ON DATED 06.12.2018 AT 10:00 AM THROUGH VIDEO CONFERENCE UNDER THE CHAIRMANSHIP OF DR. B.S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting through Video Conference (VC) was started by welcoming all the members and the agenda was discussed and actions taken are as under:

Agenda No. 1: Confirmation of the proceedings of 43rd MIDH meeting.

The minutes of 43rd MIDH meeting which was held on dated 24.11.2018 were circulated vide memo no. 5531-52/Hort-APO/NHM/5/XI/IV dated 27.11.2018 to all concerned. As no comments were received from any quarter, so the minutes of 43rd meeting were confirmed.

Agenda No. 2: Action Taken Report of previous meetings.

Due to paucity of time of the slot for VC room the ATR of previous meetings was not taken up. The same will be considered in next meeting.

Agenda No. 3: Review of Component-wise progress up to date.

MD reviewed the Component-wise Physical & Financial achievements under MIDH scheme.
