MINUTES OF 27th MIDH MEETING HELD ON DATED 31.07.2017 AT 09:30 AM AT HTI, UCHANI, KARNAL UNDER THE CHAIRMANSHIP OF DR. B. S. SEHRAWAT, MISSION DIRECTOR, HSHDA, HARYANA, PANCHKULA.

The meeting was started by welcoming all the members and the agenda was discussed and actions taken are as under:-

Agenda No. 1: Confirmation of the proceedings of 26th MIDH meeting.

The minutes of 26th MIDH meeting which was held on dated 12.06.2017 were circulated vide memo no.1407-40/Hort-APO/NHM/5/XI/III dated 16.06.2017. As no comments were received from any quarter, so the minutes of 26th meeting were confirmed.

Agenda No. 2: Action Taken Report of previous meeting.

The action taken report on the decisions taken in the previous meetings of MIDH was reviewed in detail and the following decisions were taken:-

Agenda No. 3: Component-wise review of progress made under MIDH scheme for the month of June, 2017.

The component-wise physical & Financial expenditure was reviewed by Mission Director. In this regard, MD has directed to all MS, DHMIU that the physical and financial targets should be achieved well in time so that GoI may be requested for release of 2nd installment.

Following decisions were taken during review of components:

3.1 Govt. of India has decided to cover 5.00 lakhs beneficiaries under MIDH for DBT. Haryana State has been allocated target of 20,000 beneficiaries to be covered under DBT. The targets have been distributed among districts as per their Annual Action Plan for the year 2017-18.

(Action taken by: All MS, DHMIUs)

3.2 MD has reviewed the district-wise achievements reg. number of beneficiaries under various components. It was found that a total of 3209 beneficiaries has availed the assistance through DBT. It was observed that some districts have low achievements as per table given below:-

It was decided that in districts where nos. of beneficiaries are less than 100 the warning should be issued to the concerned Member Secretaries and the salary of concerned DHC and Field Supervisor should be hold till considerable achievement of the district. In District Panchkula only 3 beneficiaries have availed assistance against 111 registered farmers. It shows clear negligence on the part of MS, DHMIU, Panchkula. Therefore, the DDO power of this officer under MIDH be withdrawn with immediate effect. Govt. may also be informed for further action accordingly.

(Action taken by: EO, MS, DHMIU, Jhajjar, Kurukshetra, Mewat, Palwal, Panchkula, Rohtak)

3.3 Under the component of establishment of new gardens the achievements was low. MD instructed HC-I to prepare the district wise detailed report and submit within a week.

(Action taken by: HC-I)

3.4 Under the component of Flowers, the targets should be achieved in the month of October-November accordingly.

(Action taken by: All MS, DHMIUs)

3.5 Under the component of Pollination support through Bee-Keeping, the farmers should be asked to purchase bee-boxes from IBDC Ramnagar to avail subsidy under MIDH. The training under the component will be held from 07-11 August, 2017 at IBDC, Ramnagar particularly for SC candidate.

(Action taken by: DDH/IBDC Ramnagar)

3.6 Under the component of Post-Harvest Management, marketing infrastructure and other projects, the proposals should be submitted after approval by concerned ADC-cum-Chairman DHMIU.

(Action taken by: HC-II & All MS, DHMIU)

3.7 The matter regarding the complaint of beneficiaries in case of poly/net-houses was discussed in the meeting and it was decided to constitute a committee under the Chairmanship of JDH/N to suggest any amendment in the existing guidelines of poly/net-houses for better implementation of the scheme.

(Action taken by: JDH/N, DDH/N & HC-I)

Agenda No. 4: Status of additional assistance of 15% as State Share for protected structures during 2017-18.

Under Protected Structure component, the report of Additional assistance of 15% as Extra State Share is being prepared by PSE-I. MD instructed to submit the report within a week.
