Agenda Item-4: Submission of Project proposals under MIDH.

Under MIDH scheme some activities such as cold store, Mushroom production, compost making unit, spawn making unit, refer vans, pack house, Organic farming etc are project based activities. As per operational guidelines of MIDH for project based activities the case has to be approved from the competent authority i.e. MD, HSHDA, SLEC, EMC, GoI & EC, GoI. MD, HSHDA instructed all MS, DHMIUs to submit the projects proposals till 25.07.2015 in order to start the procedure for approval. The cases have to be submitted within the targets allotted in the AAP for the year 2015-16.

Agenda Item-5: Power-point Presentation on protected structure by DHCs.

The power-point presentations on protected structures were presented by DHC, Y.Nagar and Bhiwani. MD, HSHDA instructed PSE-II to prepare standard performa for submission of reports related to protected structures and circulate in field.

Agenda Item-6: Account Branch

i. Monthly Expenditure Statement: MD, HSHDA has instructed to all the MS, DHMIUs to hand over certified hard copy of monthly expenditure statement to Accounts Officer and soft copy to JC/IT.

ii. Bank Reconciliation Report: AO appraised House that there are issues in bank reconciliation statements particularly district Bhiwani, Sirsa and Karnal. MD instructed MS, DHMIU, Bhiwani, Karnal and Jind to prepare their statement for the whole financial year 2014-15 with the help of Accounts Officer and report be submitted within 15 days. MD further instructed to conduct a special training of Accountant and Computer Operators at HTI Uchani Karnal on dated 24 & 25 July 2015. Minimum two officials from each district are required. The training will be co-ordinated jointly with AO, HQ and Trainer HTI. The budget may be utilized under MIDH scheme for 2015-16 under the component HRD.

i. **Review of Manpower & Extension of Horticulture Supervisors:** The review of manpower was done by MD, HSHDA. He instructed all MS, DHMIUs that regarding extension of services of Horticulture Supervisors, District Horticulture Consultants and other staff engaged under MIDH your recommendations are essential. He further suggested that they should honestly recommend for extension of good workers only.

MS, DHMIUs of Sonepat, Sirsa, Panchkula, Mewat and Jind requested to engage District Horticulture Consultants in their district. MD ensured to engage manpower shortly.

MD, HSHDA instructed all DHCs to move in the field after entry in attendance register & movement register.

Agenda Item-8: Any other item with the permission of Chair.

8.1 Works related to water community tank should be started within one month & completed in six months from the date of sanction. MS, DHMIUs to ensure that farmers should have sufficient quantity of irrigation of water before recommending the case for sanction.

8.2 Assistance on High value vegetable crops component of protected cultivation under MIDH should be given in two instalments of 75% & 25% i.e. Rs. 52.50 & 17.50 respectively. The first instalment will be given on 1st vegetable crop & 2nd instalment on 2nd vegetable crop.

8.3 In INM/IPM component the procurement may be done from IFFCO, KRIBHCO etc. without any empanelment.

(Action: All MS, DHMIUs)

8.4 MS, DHMIU Fatehabad & Hisar requested that they should be allowed to interchange sub-components within Mechanization component. MD, HSHDA allowed the same as per district requirement.

(Action: All MS, DHMIUs) 8.5 MD, HSHDA instructed all the MS, DHMIUs to incur the funds on SC families accordingly.

8.6 MS, DHMIU Panipat requested to conduct two day training on Post Harvest Management. MD, HSHDA instructed Cold Chain Consultant to conduct training in co-ordination with Principal HTI, Uchani, Karnal.
