(f) **State Horticulture Consultant** is required to run the affairs of Small Farmer Agri-Business Consortium Haryana (SFACH). SFACH has been formed under Department of Horticulture as an Independent Agency, which facilitate farmers to form farmers' groups and producers companies. The consultant will assist such groups for establishment of forward and backward linkages including establishment of necessary infrastructure for collective marketing of their produce and to establish linkage with Govt., Public & Private Sector.

(g) Qualification and Experience Criteria:

Applications must be qualified with experience as prescribed below:

(h) Engagement Terms:

- a. The engagement of Consultant shall be for a period of one year and renewable, if required, on successful satisfactory report of the Consultant and this engagement shall be for the project/scheme, whichever is earlier.
- b. The services of Consultant can be terminated before the contract period without any prior notice, if mis-conduct, poor performance on his part is observed.
- c. In case of Consultant has to leave his consultancy job before contract period, one has to give two months' prior notice or to deposit two months' emoluments in lieu of notice.
- d. He will be given 10 days proportionate leave during the contract period.

(i) Payment Terms:

The payment terms and other facilities should be as follows:
